## 1. Interpretation and Definitions

**Company:** Refers to Rational Biosentry (referred to as "the Company", "We", "Us" or "Our"). **Country:** Greece. **Service:** Refers to the Website and associated services.

## 2. Collecting and Using Your Personal Data

### Categories of Data Collected:

- **Identifiers:** Name, email address, IP address.
- **Personal information:** Phone number, address, financial info.
- **Usage Data:** Browser type, pages visited, time spent.
- **Sensitive Personal Information (CPRA):** Precise geolocation, account login info.

**Purposes for Collection:** To provide services, manage accounts, perform contracts, and comply with legal obligations.

## 3. GDPR Compliance (EU Users)

Under the General Data Protection Regulation, you have the following rights:

- **Legal Basis:** We process data based on **Consent, Contract Performance, Legal Obligation**, or **Legitimate Interests**.
  - **Right to Access & Portability:** You can request a copy of your data in a machine-readable format.
  - **Right to Erasure (Right to be Forgotten):** You may request we delete your data when no longer necessary.
  - **Right to Rectification:** You can request the correction of inaccurate data.
  - **Withdraw Consent:** You may withdraw consent at any time.
  - **Lodge a Complaint:** You have the right to complain to a Data Protection Authority.

#### 4. CCPA/CPRA Compliance (California Residents)

California residents are granted specific rights regarding their personal information:

- **Right to Know:** You can request the categories and specific pieces of data we collected in the last 12 months.
  - **Right to Delete:** You can request deletion of personal data, subject to legal exceptions.
  - **Right to Correct:** You may request that we fix inaccurate personal info.
  - **Right to Opt-Out:** You have the right to opt-out of the "sale" or "sharing" of your data.
  - **Right to Limit Sensitive Info:** You can limit our use of sensitive data to only what is necessary.
  - **Non-Discrimination:** We will not treat you differently for exercising your privacy rights.

- **"Do Not Track" (DNT) Signals:** Our website does not currently respond to automated DNT browser signals.
  - **Third-Party Collection:** We disclose that third parties (e.g., analytics) may collect PII about your online activities over time.
